Bids, duly signed on all pages and serially numbered, properly bound, accompanied with the Bid Security or Bid Securing Declaration, as applicable, in the form of cash, deposit through Demand Draft/ Banker's cheque/ Bank Guarantee, in the specified format, from a Scheduled Bank in India, shall be submitted personally or dropped in the Bid Box or by post in sealed envelopes upto 3.00 PM of 28.06.2016 to DISTRICT ELECTION OFFICER SRIGANGANAGAR bearing the reference to NIB and warning as: "BID FOR NIB No 01/06.06.2016 for Preparation, Supply & Integration..., NOT TO BE OPENED BEFORE 28.06.2016 of 4.00 PM."
4. Bids received after the specified time and date shall not be accepted and returned unopened.
5. The Bids shall be opened at 4.00 PM on date 28.06.2016 in the presence of the Bidders or their representatives who wish to be present.
6. The Procuring Entity is not bound to accept the lowest Bid and may reject any or all Bids without assigning any reason thereof.
7. The Bidders shall have to submit a valid 'VAT' registration and 'VAT' clearance certificate from the concerned Commercial Taxes Officer and the 'PAN' issued by Income Tax Department.
